Description

This interactive 2-day workshop covers all topics presented in the Content Outline of the CPHQ Certification. The content of the outline will be covered with discussion, real life examples of how the information should be utilized, including examples of when the content was not applied correctly in healthcare organizations. The participants are encouraged to ask questions throughout the presentation since most of the information builds throughout the 2 days. Information covered includes but is not limited to basic quality concepts, leadership, performance measurement and management, information management including tools and statistics, patient safety, and accreditation & licensure. Attendees will be able to identify areas within the CPHQ Certification Content Outline where they are strong in their knowledge and where they are weak and thus require further study, knowledge, and/or experience prior to taking the CPHQ Certification exam.
